- This Guarantee only becomes effective if the Guarantee Registration Card attached hereto is duly completed and returned to the Company within seven days of the date of purchase.
- 2. This Guarantee and Undertaking does not extend to proprietary parts, such as:
  - (a) Tyres, bulbs, speedometers, saddles, pedals, sparking plugs, chains, free wheels, etc.
  - (b) Any defect caused in the opinion of the Company by reason of neglect or mis-use or wear and tear.
  - (c) Any Moped which has been let out on hire or on which any identification marks or numbers have been altered or removed.
  - (d) Any defects in any Moped which has been repaired or altered in such a way as in the opinion of the Company to affect its reliability.

The Company does not accept responsibility for time, labour or other expenses incurred in respect of removing, dismantling, assembling, examining or transporting the Moped or any part hereof and the Company shall be entitled to recover from the Purchaser the cost of any time labour or other expense incurred by the Company in repairing or replacing any defective part. The Company does not accept responsibility for any charges expenses or costs incurred in making a claim under this Guarantee and the responsibility of the Company is limited to repair or replacement as aforesaid.
- 4. Any defective part replaced by the Company in pursuance hereof shall become the property of the Company and may be retained or destroyed by them.
- 5. The Company shall not be under any liability either under this Guarantee or otherwise for any loss injury or damage (whether to persons or property) howsoever caused whether by reason of any Moned or any part thereof being defective or otherwise.
- 6. The Moped must be the property of the original owner and must have been purchased from an accredited Auto-Vap Moped dealer at the Company's published retail selling price.
- 7. The judgment of the Company shall be final and conclusive in respect of any claim under this Guarantee and the Purchaser agrees to accept the desicion of the Company on all questions as to defects and the exchange of parts.
- 8. This Guarantee is in substitution for any other warranty or condition or other obligation of any kind whether implied by law or otherwise and is the only warranty made by the Company which will not be responsible for any representation, warranty or undertaking made by any other person whatsoever.


